Thank you for your interest in Wm. S. Haynes flutes and piccolos. We are pleased to offer you the opportunity to try a Custom Handcrafted instrument. After you have a chance to try the instrument, we can discuss, in detail, how you can order a Custom Handcrafted flute or piccolo.

Below is the protocol for a Wm. S. Haynes flute/piccolo/headjoint trial.

- ◆ The trial period is for five days.
- ◆ Please remove all jewelry before playing the instrument to prevent scratches.
- ◆ Dry the inside of the instrument after playing with the cleaning rod using a lint free cloth
- ◆ Wipe the body, footjoint, headjoint, and keys carefully to remove fingerprints.
- ◆ Keep the instrument in the case to insure it is protected when not being played.
- ◆ You must be 21 years or older to request a trial
- ◆ If the instrument is lost, stolen, or damaged, you will agree to pay the full purchase price of the instrument within 48 hours of the incident.

The Wm. S. Haynes Company charges \$55 per instrument and \$25 per headjoint trial. This covers shipping both ways and insurance. At the completion of the trial period, please pack the flute in the box provided and affix the label provided. Take the box to a UPS location for shipping or call UPS for a pick-up. If you purchase a Wm. S. Haynes flute, piccolo, or headjoint within 30 days of your trial, this amount will be refunded to you. Any damage due to misuse or neglect will be repaired by Haynes at your expense. Haynes will charge your credit card at the rate of \$85 per hour.
